WHEREAS, the Plan was prepared in accordance with FEMA requirements at 44 C.F.R. 201.6;



WHEREAS, adoption by the Council demonstrates the Town's commitment to hazard mitigation and achieving the goals outlined in the Plan;


WHEREAS, the Council has afforded the citizens an opportunity to comment and provide input in the Plan and the actions in the Plan; and

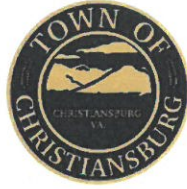



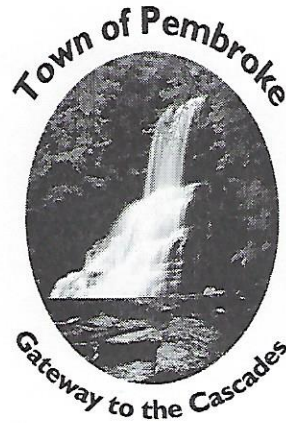
