SUBJECT: February 11, 2009 Meeting - Administrative Staff Report

Substitute Annual Meeting – An annual meeting has not been held for 2008-09, nor have officers been elected for the 2008-10 two year terms. Designation of the February 11 meeting as the annual meeting will allow receipt of and possible action on a slate of officers from the nominating committee.

Confirmation of Engagement of Executive Director Designee - The terms of engagement of Joe Morgan have been previously circulated and should be confirmed.

Administrative Team Transition Scope of Services Review and Approval – The Scope of Services which will guide the staff activity through the April 8 Authority meeting is attached. Authority members are encouraged to suggest additional items that should be reviewed in preparing a Program of Work for 2009-10.

Establishing an Executive Committee – The organizational documents of the Authority provide for an Executive Committee. It is recommended an Executive Committee composed of the Authority Officers and each Participation Committee Chairman or Vice-Chairman be appointed on a trial basis for 6 months, after which the specific duties can be made a part of the Authority By-Laws. During the 6 month trial period, the Executive Committee can meet at least bi-monthly and give direction to the staff on any administrative action and recommend policy decisions for confirmation by the full Authority.

Nominating Committee Report – Chairman McKlarney appointed the following Nominating Committee, which may have a report on a slate of officers: Doug Chittum; Bob Isner; John Hawley; and Ken Vittum. The nominating committee will meet at 3:30 p.m. on February 11 at the Competitiveness Center.

HOUSE BILL NO. 2641

Offered January 23, 2009

A BILL to amend and reenact § 15.2-6415 of the Code of Virginia, relating to the Virginia Regional Industrial Facilities Act.

Patron—Fralin

Referred to Committee on Counties, Cities and Towns

Be it enacted by the General Assembly of Virginia:

1. That § 15.2-6415 of the Code of Virginia is amended and reenacted as follows:

§ 15.2-6415. Dissolution of authority; withdrawal of locality.

A member locality of an authority may withdraw from the authority only (i) upon dissolution of the authority as set forth herein, or (ii) upon a resolution adopted by the governing body of a member locality and after satisfaction of such member locality's legal obligations, including repayment of its portion of any debt incurred, with regard to the authority, or after making contractual provisions for the repayment of its portion of any debt incurred, with regard to the authority. Whenever the board determines that the purpose for which the authority was created has been substantially fulfilled or is impractical or impossible to accomplish and that all obligations incurred by the authority have been paid or that cash or a sufficient amount of United States government securities has been deposited for their payment, or provisions satisfactory for the timely payment of all its outstanding obligations have been arranged, the board may adopt resolutions declaring and finding that the authority shall be dissolved. Appropriate attested copies of such resolutions shall be delivered to the Governor so that legislation dissolving such authority may be introduced in the General Assembly. The dissolution of an authority shall become effective according to the terms of such legislation. The title to all funds and other property owned by such authority at the time of such dissolution shall vest in the member localities which have contributed to the authority in proportion to their respective contributions.
