Re: Participation in NRVRC meetings through Electronic Communication Means Policy

When the Governor has declared a state of emergency in accordance with section 44-146.17 of the Code of Virginia, it may become necessary for the NRV Regional Commission to meet by electronic means as outlined in Section 2.2-3708.2 of the Code of Virginia as amended. In such cases, the following procedure shall be followed:

1. The NRV Regional Commission will give notice to the public or common interest community association members using the best available method given the nature of the emergency, which notice shall be given contemporaneously with the notice provided to members of the NRV Regional Commission.

2. The NRV Regional Commission will make arrangements for public access or common interest community association members access to such meeting through electronic means including, to the extent practicable, videoconferencing technology. If the means of communication allows, provide the public or common interest community association members with an opportunity to comment

3. The NRV Regional Commission will otherwise comply with the provisions of § 2.2-3708.2 of the Code of Virginia. The nature of the emergency, the fact that the meeting was held by electronic communication means, and the type of electronic communication means by which the meeting was held shall be stated in the minutes of the NRV Regional Commission meeting.

Re: April 2021 Financial Statements

The April 2021 Agencywide Revenue and Expenditure Report and Balance Sheet are enclosed for your review. Financial reports are reviewed by the Executive Committee prior to inclusion in the meeting packet.

The Agencywide Revenue and Expense report compares actual year to date receipts and expenses to the FY20-21 budget adopted by the Commission at the June 25, 2020 meeting. The financial operations of the agency are somewhat fluid and projects, added and modified throughout the year, along with the high volume of Workforce program activities, impact the adopted budget. To provide clarity, Commission and Workforce Development Board activities are separated on the agencywide report.

As of month-end April 2021 (83% of the fiscal year), Commission year to date revenues are 69% and expenses are 70% of adopted budget. The two largest budget expense lines, Salary and Fringe, are ahead of budget at 95% and 97%, respectively. This is due to additional staff being hired to support the Business Continuity Team. Revenue is secure to cover these expenses.

Looking at the balance sheet, Accounts Receivable is \$582,755. Of this total, Workforce receivables are \$364,132 (62%) and current. The Executive Committee reviews all aged receivables over 60 days and no receivables are deemed uncollectible. Net Projects (\$126,898) represents project expenses, primarily benchmark projects, that cannot be invoiced yet and posted to receivables.

The Army is requesting a project review for a development project at the Radford Army Ammunition Plant (RFAAP) in Pulaski County, Virginia and Montgomery County, Virginia. This undertaking is proposed to replace the current and aging Nitroglycerin production facility with the construction of a consolidated, efficient, reliable, and modern nitrate ester production facility at RFAAP that is compliant with all applicable laws and regulations. The proposed action is needed to meet the Department of Defense's current and estimated future nitrate ester production requirements in a consolidated, safe, cost effective, energy efficient, and environmentally compliant manner. The Army anticipates the Area of Potential of Effect (APE) for this undertaking would include the areas where ground-disturbing activities would occur. Any comments you may have on the APE for this undertaking are requested.

As part of the National Environmental Policy Act (NEPA) compliance process, we request your review of the proposed project site, along with any information about wetlands, surface waters, or other resources that may occur on or near the property. Our intent is to address your agency's concerns and incorporate any recommendations into the planning process at the earliest possible time. Your response will be incorporated into the Environmental Assessment.



This letter is in response to the scoping request for the above-referenced project.

As you may know, the Department of Environmental Quality, through its Office of Environmental Impact Review (DEQ-OEIR), is responsible for coordinating Virginia's review of federal environmental documents prepared pursuant to the National Environmental Policy Act (NEPA) and responding to appropriate federal officials on behalf of the Commonwealth.

DOCUMENT SUBMISSIONS

In order to ensure an effective coordinated review of the NEPA document, notification of the NEPA document documentation should be sent directly to OEIR. We request that you submit one electronic to <u>eir@deq.virginia.gov</u> (25 MB maximum) or make the documents available for download at a website, file transfer protocol (ftp) site or the VITA LFT file share system (Requires an "invitation" for access. An invitation request should be sent to <u>eir@deq.virginia.gov</u>.).

The NEPA document should include U.S. Geological Survey topographic. We strongly encourage you to issue shape files with the NEPA document. In addition, project details should be adequately described for the benefit of the reviewers.

ENVIRONMENTAL REVIEW UNDER THE NATIONAL ENVIRONMENTAL POLICY ACT: PROJECT SCOPING AND AGENCY INVOLVEMENT

As you may know, NEPA (PL 91-190, 1969) and its implementing regulations (Title 40, *Code of Federal Regulations*, Parts 1500-1508) requires a draft and final Environmental Impact Statement (EIS) for federal activities or undertakings that are federally licensed or federally funded which will or may give rise to significant impacts upon the human environment. An EIS carries more stringent public

participation requirements than an Environmental Assessment (EA) and provides more time and detail for comments and public decision-making. The possibility that an EIS may be required for the proposed project should not be overlooked in your planning for this project. Accordingly, we refer to "NEPA document" in the remainder of this letter.

While this Office does not participate in scoping efforts beyond the advice given herein, other agencies are free to provide scoping comments concerning the preparation of the NEPA document. Economic Development:

• Federal guidance for use of American Rescue Plan funding was released in May. The five primary funding objectives include: support urgent COVID-19 response efforts; replace lost revenue for governments to strengthen support for vital public services and help retain jobs; support immediate economic stablization for households and businesses; Address systemic public health and economic challenges that have contributed to inequal impact of the pandemic.

Transportation:

- Governor Northam was in Chrisitansburg May 5th to announce the Western Rail Initiative. The program will include passenger service to the New River Valley, a second daily train on the Northeast Corridor and a significant investment by the Commonwealth to purchase right of way from Norfolk Southern.
- The Valley to Valley Trail planning project will hold a stakeholder meeting in late May before releasing a survey to the public and holding a public meeting. The stakeholder meeting will be an opportunity to review potential alignments and ask questions of the consultant before the public process gets underway.

Natural Resources:

- The ReNew the New annual fall clean-up event will take place on August 28th. Be on the look out for community-specific event information for times and locations.
- The New River Water Trail expansion project team met on 5/17 with a focus on current marketing of the region. The Destination Marketing Organizations and Onward NRV shared their marketing plans. The expansion project will be scheduling community-specific site meetings to discuss improvements needed to infrastructure such as launches and/or sign locations.

Regional:

- The Business Continuity Team (BCT) is winding down the large-scale vaccine clinics with the last held at Lane Stadium on 5/18. Focus has shifted to supporting schools with vaccine clinics before schools close for the summer. The VA Dept of Emergency Management is also deploying a mobile clinic in the region starting on 5/23. There will be 13 clinics over 13 days offering Johnson and Johnson single-dose vaccine. BCT staff helped schedule clinic locations.
- Virginia Housing recently announced a program dedicated for planning district/regional commissions in Virginia. Based on population, our organization will have access to \$2.0M to assist with housing units being built and supporting regional initiatives identified in the recently completed Regional + Local Housing Study.

Commission:

- The Berkley Group presented findings from the Wage/Compensation Study to the Executive Committee on 5/19.
- NexGen Media was selected to assist with the Commission website update. A full-staff workshop was held on 5/4 and sub-committees have met to provide content to the developer.

At the May Commission meeting, Joe McKinney, Executive Director, and Mirielle Burgoyne, Deputy Executive Director/Director of Government Affairs, with NADO will join the meeting via Zoom to provide a presentation on federal legislation and programs. There is a tremendous amount of activity underway at the federal level in response to the pandemic along with initiatives being proposed by the Biden Administration. Key topics NADO is tracking include the American Rescue Plan, US Economic Development Administration, transportation reauthorization and proposed infrastructure packages. Following the NADO presentation Commissioners will have time to ask questions.

Re: 2021-22 Comprehensive Economic Development Strategy (CEDS) and EDA CARES Act Recovery Program- Progress Update

NRVRC staff are modifying the typical annual update cycle for the region's Comprehensive Economic Development Strategy (CEDS) to align with the ongoing EDA CARES Act Recovery Assistance award, which the Commission received in July 2020. This two-year award complements NRVRC's existing EDA-supported CEDS planning process, providing additional staff and funding to improve the CEDS format and accessibility, revise the CEDS to reflect a focus on top-priority pandemic recovery economic development projects, and develop strategies to improve the region's economic resilience and ability to withstand future shocks.

NRVRC staff began the CEDS content update process this winter, and reconvened the CEDS committee in March 2021 for the first of several meetings to provide input for this expanded CEDS update. CEDS committee meetings will focus on reviewing and critiquing online CEDS content as it is developed over the upcoming year, and developing regional projects for each of the CEDS 'priority area' strategies. The May meeting focused on the workforce topic area, with meetings in June, and throughout the fall and winter, focusing on small business development, infrastructure, etc. The revised strategies and projects developed at this meetings will provide the initial content for the online CEDS 'storymap,' which will largely replace the existing report format PDF document.

NRVRC staff will be present at the May commission meeting to provide a brief update on CEDS committee discussions to date, and present templates of the proposed format for the online CEDS revisions.
