INTRODUCTION

The New River Valley Comprehensive Economic Development Strategy (CEDS) documents the region's economic development program to help continue federal and local partnerships address the economic development of the region. The CEDS process includes analysis, vision, action plan, and evaluation. This process provides a program that helps create jobs, foster a more stable and diversified economy, and improve living conditions in the region.

This annual report summarizes the changing conditions in the region during fiscal year 2012. As a regional development strategy, Virginia's New River Valley Strategic Plan (Vision 2020: Community First, prepared in 2003) addresses the planning needs of the CEDS for the Economic Development Administration and the Area-wide Action Plan for the Appalachian Regional Commission. Figure 1 attempts a graphic depiction of the myriad of community and organization involvement necessary for the development of the regional strategic plan. Though no organization has this planning process as their central activity – strategic planning is a collaborative effort with all of these organizations and groups represented and actively engaged.

CEDS emerges from a continuous planning process. This Annual Report of the New River Valley CEDS seeks to document and evaluate the process, effectively updating the CEDS, while responding to the reporting requirements, review, and critique of the previous CEDS for the Economic Development Administration. Rather than a single stand-alone section, evaluation is integrated as a continuous feedback loop in each part of the process and report.

The CEDS Committee includes the Principles of the Investment Policy Guidelines in its project evaluation process. The Guidelines continue to be utilized in the development of CEDS projects.

Included in the FY09 work program was the preparation of the FY 09 major update of Vision 2020. The "new" CEDS, Community First...Regional Partners in a Global Marketplace, was led by the Commission and a Vision 2020 Steering Committee made up of 18 community and civic leaders. This year's (FY14) update was developed based on the goals, objectives, strategies, and projects related to seven priority areas of: 1) Coordinated Business Assistance and Entrepreneurial Support; 2) Preparation and Continued Support of Qualified Workforce; 3) Available Land, Quality Infrastructure, and Affordable Housing; 4) Attracting New Business to the Region; 5) Regional Marketing/Awareness to Promote the New River Valley; 6) Preserve Natural and Historic Areas; and, 7) Business Friendly Governance and Representation.

ORGANIZATION AND MANAGEMENT

The New River Valley Planning District Commission (PDC) was created in September 1969 by the City of Radford, the Counties of Floyd, Giles, Montgomery, and Pulaski, and the Towns of Blacksburg, Christiansburg, and Pulaski. As key players in the regional economy, Virginia Tech and Radford University joined the Commission in July 2000 along with the Towns of Floyd, Narrows, Pearisburg, and Rich Creek. Twenty-four representatives of these entities make up the Board of Commissioners.

A CEDS Committee was formed with the approval of the PDC in FY 11. 15 public and private representatives from the New River Valley were identified and invited to participate on the CEDS Committee originally. Five new members were added to the CEDS Committee in FY 2012, and five more in 2013. The CEDS Committee was charged with the task of identifying projects, reviewing goals and objectives, and reviewing the projects and ranking criteria for those projects. Upon completing those tasks, the CEDS Committee made recommendations to the PDC for final approval of the CEDS. The PDC works closely with several other regional groups that take leading roles in pursuing economic development projects and funding to advance the quality of life in the New River Valley (see Figure 1, page 6). These include the New River Valley Economic Development Alliance, the New River/Mount Rogers Workforce Investment Board, the Partners for Self Sufficiency (an organization formed by the local departments of social services in the region), Virginia's First Regional Industrial Facility Authority, the New River Valley Land Trust, and the Community Foundation of the New River Valley.

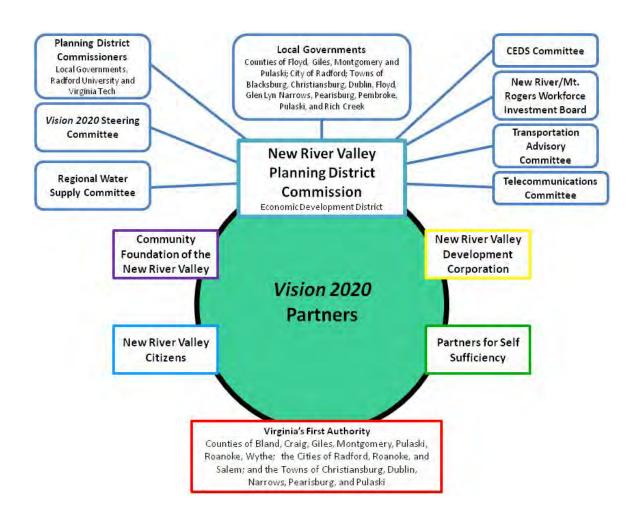
This spring, memoranda were sent to all the localities that participate in the New River Valley Planning District (PDC), and to collaborative partners. Each was asked to submit a list of projects that they were working on or considering. Then each group reviewed the status of current projects, and planning for the future. Staff at the PDC compiled the information for this report. The minutes of the CEDS Committee and PDC meetings are attached in Appendix I. All of the Economic Development District's Board minutes are available on the web at www.nrvpdc.org.

New projects and programs emerged and were refined this year. These are included in this document. In addition to projects, the Goals and Objectives for the Vision 2020 process were updated. The updated Goals and Objectives are on the following pages, and the revised evaluation criteria are included in the Annual Project Package Report Section.

The staff for the CEDS Committee includes Kevin Byrd, Executive Director of the Planning District Commission; Bradley Mecham, Regional Planner; Kim Thurlow, Project Coordinator; and Carol Davis, Community Outreach Facilitator.

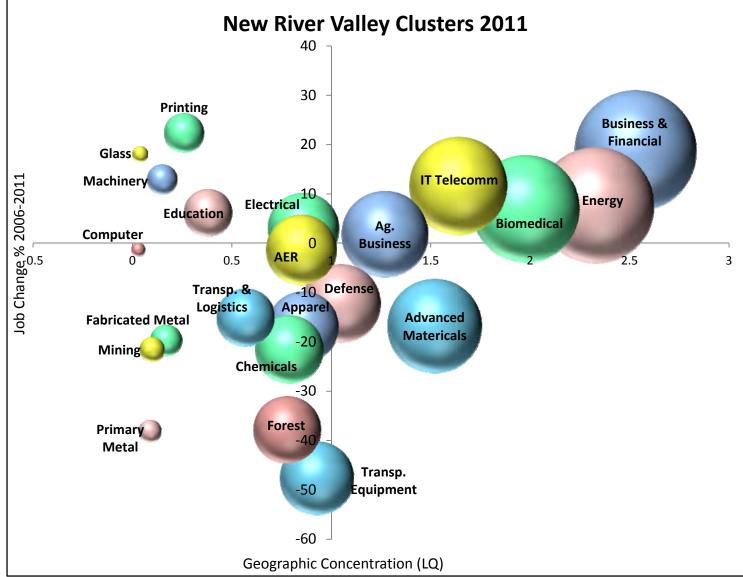

CLUSTER ANALYSIS

The New River Valley Planning District Commission worked with the Southern Rural Development Center (SRDC) at Mississippi State University to complete a cluster analysis of the New River Valley. According to the Economic Development Administration, economic clusters are geographic concentrations of interconnected industries and supportive organizations that make regions uniquely competitive for jobs and private investment. To perform the analysis, the SRDC researched employment concentrations within economic sectors throughout the region while measuring the job growth or loss within the specified cluster. As part of this analysis, pre- and post-recession time periods were evaluated to demonstrate the strengths and weaknesses of clusters within the NRV. Following is a chart that shows NRV economic sectors divided into quadrants. Those in the top right quadrant are considered to be the strongest in the region with strong job growth and a geographic concentration in that sector.



*AER - Arts, Entertainment and Recreation

The cluster chart shows five economic sectors that are growing in specialization and employment. These clusters are: 1) Business and Financial Services; 2) Energy; 3) Biomedical; 4) Information Technology and Telecommunications; and 5) Agribusiness. In cluster theory, the top right quadrant, or 'stars', highlights the standout industries that define the region's economy that also have potential to keep growing in specialization and bring additional employment. The top left quadrant shows 'emerging' clusters that lack geographic concentration, but can grow into the 'star' category due to high job growth. These 'emerging' clusters need strategies focused on developing the workforce and entrepreneurial assistance. The bottom right quadrant shows sectors that still have geographic concentration but are losing that concentration due to job losses. These sectors need special attention if there is to be potential for long-term success in that sector. Finally, the lower left quadrant shows economic sectors that do not have geographic concentration and have lost jobs. Generally speaking, these sectors lack competitiveness unless new industries can be attracted to the region and bolster that sector.

This analysis will serve as a guide for future strategy development with regards to workforce training, entrepreneurial development and resource allocation. This provides a base for discussion and development of future strategies.

GOALS AND OBJECTIVES

Virginia's New River Valley VISION 2020 "Community First...Regional Partners in a Global Marketplace" Updated April 2013

The New River Valley Planning District Commission (Economic Development District) leads the continuous planning process for economic development in Virginia's New River Valley region.

A major update to Vision 2020 was completed in 2003. The process started with a Celebration of the accomplishments in the Region since the 1995 version of the regional strategic planning document was prepared, and "Community First" emerged as a theme. During 2009 the Commission undertook the second major update of Vision 2020. There was considerable concern about the global economy, the decline in manufacturing, and the focus of education. "Community First" continued to be relevant, however it was broadened into a regional context recognizing the need to be both a supplier as well as a consumer in the global marketplace. Vision 2020 has since taken on the title "Community First...Regional Partners in a Global Marketplace".

The Economic Development District works closely with localities and several regional groups that take key roles in pursuing economic development projects and funding to advance the quality of life in the New River Valley. The Goals and Objectives from the 2009 Vision 2020 update were revised in March 2013 and are presented here in the seven priority areas:

1) Coordinated Business Assistance and Entrepreneurial Support; 2) Preparation and Continued Support of Qualified Workforce; 3) Available Land, Quality Infrastructure, and Affordable Housing; 4) Attracting New Business to the Region; 5) Regional Marketing/Awareness to Promote the New River Valley; 6) Preserve Natural and Historic Areas; and, 7) Business Friendly Governance and Representation.

Priority 1: Coordinated Business Assistance and Entrepreneurial Support.

Goal: Establish an environment that fosters the growth of existing businesses and supports entrepreneurs from startup stage through maturation.

Objective 1: Optimize existing resources for entrepreneurs and small businesses and promote collaboration between these resources.

Objective 2: Increase the number of jobs created through entrepreneurial start-ups and expansions in the New River Valley.

Business Assistance and Entrepreneurial Support Key Strategies

- 1) Promote cooperation between the Radford Small Business Development Center, VT KnowledgeWorks, New River Community College, etc.
- 2) Create new and support existing financing opportunities for business/industry expansion, including venture capital.
- 3) Encourage the use of locally developed technology and intellectual property in manufacturing and other industries.
- 4) Organize creative financing programs and improve entrepreneurs' access to capital.
- 5) Increase small business support services through provision of community e-commerce space as well as trainings (social media, computer, etc.).
- 6) Link local industries with technology and research capabilities of Virginia Tech, Radford University, and New River Community College.

Priority 2: Preparation and Continued Support of Qualified Workforce

Goal: Prepare the New River Valley workforce for present and future employment in growing employment sectors.

Objective 1: Train and re-train workers for higher skills and productivity in the modern economy.

Objective 2: Improve the industry/education interface at all levels.

<u>Preparation and Continuation of Qualified Workforce Key Strategies</u>

1) Utilize the Community College or the One-stop Centers to assist businesses seeking trained employees or training of employees requiring enhanced skills.

- 2) To establish partnerships between industry/business and all levels of education by implementing an integrated workforce curriculum that provides students with more "real world" learning opportunities
- 3) Expand existing and explore new opportunities for business training and professional development programs.
- 4) Create a Youth Entrepreneurial Center for business and civic development and practice.

Priority 3: Available Land, Quality Infrastructure, and Affordable Housing

Goal: Maintain existing and deploy additional infrastructure to meet the needs of businesses and residents.

Objective 1: Create an affordable, accessible and interlinked public transportation network that connects population centers with major employment centers.

Objective 2: Strengthen the economic position of downtown commercial districts.

Objective 3: Improve the region's telecommunication network to attract new firms, assist existing firms, and educate citizens.

Quality Infrastructure Key Strategies

- 1) Coordinate and maximize the use of existing public and private transportation resources focused on employment mobility.
- 2) Seek diversification and mixed use redevelopment of downtown commercial districts.
- Deploy a diverse network of fiber optics throughout the region to serve businesses and residents.
- 4) Create utility standards for service providers to follow and coordinate public digging to minimize costs and disturbances.
- 5) Seek creative and cooperative regional financing strategies for major infrastructure needs.
- 6) Ensure adequate public utilities are in place for businesses and residents.
- 7) Coordinate and adopt creative approaches to encourage the creation of affordable housing for all age groups.

Priority 4: Attracting New Business to the Region

Goal: Attract new industries that will complement the region's economy, strengthen interindustry linkages, and utilize the region's labor force.

Objective 1: Develop and strengthen the role of international trade and commerce in the economy of the New River Valley.

Objective 2: Increase the region's supply of ready and available industrial and other economic development properties.

Attracting New Business Key Strategies

- 1) Seek firms with an international focus to utilize the strategic assets of the New River Valley International Airport, Foreign Trade Zone and Commerce Park.
- 2) Recruit outside firms seeking a trained and skilled labor force, low utility costs, high quality industrial space, and convenient highway access.
- 3) Recruit outside firms that currently have significant supplier relationships with New River Valley companies.
- 4) Develop regional properties tailored to the needs of targeted industry sectors.

Priority 5: Regional Marketing/Awareness to Promote the New River Valley

Goal: Expand the regional identity and brand to increase the marketability of the region for businesses and tourists.

Objective 1: Improve the region's ability to market itself and respond to the needs of new industrial, research, and technological prospects.

Objective 2: Realize the region's tourism development potential and ability to market itself as a culturally and naturally unique tourism destination.

Regional Marketing/Awareness Key Strategies

- 1) Expand multi-regional marketing campaigns involving the New River Valley Economic Development Alliance, and similar organizations throughout Western Virginia.
- 2) Study the feasibility of a Destination Marketing Organization or Convention and Visitors Bureau and develop implementation strategies based on findings.
- 3) Participate in, support, and encourage southwestern Virginia initiatives such as 'Round the Mountain, Crooked Road, and Heartwood Center.

4) Identify, develop, and package the region's inventory of historical assets and arts and cultural activities, natural features, and events to support external marketing.

Priority 6: Preserve Natural and Historic Areas

Goal: Preserve the natural and historic assets within the region to protect the character and quality of the regional environment.

Objective 1: Manage the impacts of existing and future land uses in order to preserve the character and quality of the regional environment.

Objective 2: Increase the development and support of local family farms.

Preserve Natural and Historic Areas Key Strategies

- 1) Develop educational, networking and mentoring programs to support and encourage the continuation of family farms; including farmers markets and regional aggregation facilities.
- 2) Implement "Farms to School" programs, which would widen the market for locally grown produce and products.
- 3) Utilize tourism assets as a way to preserve open spaces, historic sites and key natural attractions.
- 4) Improve land use planning and practices to preserve the region's rural character.

Priority 7: Business Friendly Governance and Representation

Goal: Promote a business friendly environment through governments cooperating with businesses at the local level and advocating for them at the state and federal levels.

Objective 1: Bring a voice to the policy table on behalf of the region.

Objective 2: Ensure the safety of the region's citizens.

Governance Key Strategies

- 1) Seek representation on State Commissions and Committees.
- 2) Provide input to State from regional economic development organizations and planning districts.
- 3) Support police, fire, and medical operations throughout the region.
- 4) Provide youth programs and support.

EVALUATION OF PREVIOUS YEAR'S ACTIVITIES

The 2013 Project Package represented the priorities of the region as of May 2012. It is, therefore, imperative to look again critically at that list. First, it is ascertained whether or not the project is still desired by the named agency. If not, it will be dropped from the new list. If the project is still desired (indicated by an "X" in the table), it is evaluated in terms of status (see **New River Valley 2013 Annual Project Package Evaluation, page 31**). The status categories of "planning, funding, and completed" are explained below. If a project has been completed or is fully funded, it will not be included in the 2014 Project Package.

Planning

Planning, in this instance, is a general term used to indicate ongoing development of a project. This may include any of the following activities:

- holding project meetings
- studies including feasibility studies, engineering or architectural reports
- completion of required forms, permits, processes
- or any other activity indicating active pursuit of the project.

Funding

Funding is the critical yet often elusive component for bringing a project to fruition. The formal request for funding from Federal agencies is often a two-step process which begins with a preapplication. If the project is viewed favorably, the sponsoring agency is invited to submit an application. A project is considered "Funded" following award notification when grant agreements are completed.

Completed

A construction project is considered "completed" when the construction is entirely finished. A program (non-construction) is considered "completed" when it is implemented.

Additional Concepts for Future Development

Though many projects exist to support the identified Goals and Objectives, there are also supporting concepts that do not have specific projects yet. This section outlines some of those concepts. Many of these projects comprise an economic development approach that links directly into the *Community First* goals of having an optimum level of employment; an income level equal to or better than the state's average; and a beneficial living environment.

Leadership

The Leadership category highlights opportunities in the New River Valley for promoting and sustaining leadership development and engagement in our local and regional community. The following concepts do not currently have an active project associated with them but are in the process of partnership and timeline development.

Youth Business and Civic Leadership Development:

Provide hands-on training and mentoring opportunities through business and civic organizational partners in the program.

Youth Leadership Recognition Program:

Create award/program that recognizes and rewards youth leadership efforts in the civic and business sectors of the region.

Community Awareness Workshop for Elected Officials:

Establish short course for elected officials and corporate leaders highlighting community development issues and opportunities.

Economic Development

The arena of economic development showcases the New River Valley's approach to creating a sustainable, diverse regional economy that is also globally competitive. The following concepts do not currently have a project associated with them but eventually will in the future.

Niche Development for Downtowns:

Define downtown niches for cooperative marketing of unique characteristics of NRV downtowns.

Niche Farming:

Agri-tourism for a regional community of farmers.

Sustainable Agriculture:

Feasibility Studies of agro-tourism and providing outlets for locally-produced dairy products.

Explore approaches to expand public/private partnerships:

There are increasing pressures for the development of public/private partnerships to expand the public assistance in providing basic infrastructure to a more active role in the development of corporations. The cost and risk involved in the formation of corporations has entrepreneurs seeking business acceleration assistance from the public sector. Defining and legitimizing this role is requiring innovation in establishing such partnerships.

Education & Training

In the area of Education and Training, the NRV has reached the critical point of needing to support workforce and education development programs aimed at establishing businesses and industries locally. With the economic crisis at the state and federal levels creating great inequities in service delivery, it is crucial that the New River Valley strategic plan for educational advancement be directed at building companies and a workforce for the global economy here at home.

Address the teacher shortage:

Develop incentives in collaboration with local governments, school boards and business sector to attract and retain qualified teachers to this area.

Address education funding:

Seek public/private partnerships and regional collaborations to offset state under-funding of education.

Regional Educational System:

Create New River Valley collaborative model to address alternative, advance placement and adult education needs in the region both physically and through the use of technology.

Health & Human Development

Health and human development put a personal face on the region's approach to supporting its citizens.

Evaluate and Pilot Human Service Delivery Programs:

Using higher education partners in the region, assess service delivery in the New River Valley and develop model for increasing effective and efficient service delivery.

Quarterly Agency/Community Sessions:

Create forum for community and human se rvice agencies to gather and strategize ideas for higher efficiencies in service delivery and agency/client interface.

Natural & Cultural Environment

The Natural and Cultural projects represent the importance our citizen's place on the often intangible aspects of quality of life that can make a place one that people are proud to call home.

Adopt-a-Stream:

Support for state-run program.

Baseline Wildlife & Habitat Inventory:

Build baseline landscape-level wildlife species and habitat inventory for the greater New River watershed.

Citizens' Water Atlas:

Develop a database for water resources, including threats in the watershed.

Compliance Study of Erosion and Sedimentation Control Practices:

Examine compliance rates of erosion/sedimentation control practices.

Erosion Control:

Educate landowners on erosion control and restoration of eroded areas.

Support and Promote Christiansburg Institute:

Assist in funding and program development to support this important historic and cultural asset of the region.

Regional-link Trail System:

Create prioritized map of trail connections to link all alternative transportation pathways in the New River Valley.

Physical Infrastructure:

A sound physical infrastructure is the base on which all other projects are built. There are many needs in the area of physical infrastructure including **water and sewer** as well as **technology** infrastructure. Beyond these needs, additional concepts for physical infrastructure are listed below.

Bikeway Network:

Plan and create a network of bikeways through the NRV that connects towns, scenic areas, and historic areas.

Regional Civic/Convention Center:

Create event/conference center to provide space for large attractions and events.

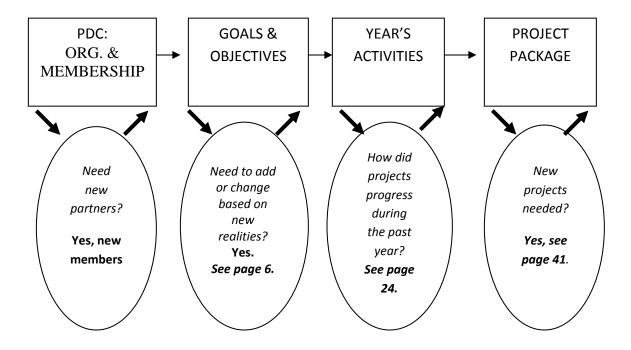
EVALUATION: AN INTEGRATED APPROACH

As is apparent throughout this document, evaluation is an integrated part of the CEDS process. Given the continuous nature of this planning process, integration of evaluation into every step is one method of assuring a self-adjusting, constantly "fresh" plan and process. (See Figure 2) Important questions that are asked along the way as part of a feedback loop include:

- □ Has the situation changed?
- □ Are new partners needed?
- Do Goals, Objectives, and Projects need to be changed in light of current Strengths, Weaknesses, Opportunities and Threats (SWOT)?

This process is followed annually as the CEDS is reviewed and the Annual Reports prepared. Goals and Objectives as well as projects are evaluated.

Evaluating Completed Projects

Following completion of a project, it is desirable to measure the effectiveness of the project and more specifically the return for the money spent. While larger goals such as a diversified economy, higher wages/incomes and improved quality of life are not easily detectable as they may be affected by most single projects, there are measurable related outputs. These include data such as number of jobs created and amount of private investment generated directly and indirectly.

Cautions and Concerns

While this is a straightforward query, answers are not so simple nor easily obtained. These projects do not take place in a laboratory where all external factors are controlled; rather each project is but one small part of countless variables in a huge picture that is the global economy. Moreover, the sum of a program of well-developed, mutually supporting projects is much greater than the sum of the parts.

For example, singularly developing a Regional Educational System to address alternative and advanced placement students needs regionally would not necessarily help incomes or unemployment in the region. Singularly developing a large Commerce Park to attract high tech industry will not help local economies if it sets idle. However, if a well-trained, well-educated work force is developed and physical space and infrastructure is available to high tech firms simultaneously, the likelihood of significant positive outcomes is great. Therefore, a truly integrated economic development strategy with multi-dimensional projects and components cannot be accurately measured in a single dimension. A means of simultaneously measuring relationships and synergies must be developed. A better question in many instances may be, "Is a good new piece of the puzzle now in place?"

Another difficulty in measuring outputs is that the timing is uncertain. In some cases, the greater the potential reward in the end may require a longer timeframe.

One of the most significant limiting factors in evaluation concerns the collection of data. To truly account for the success of a program would require tracking every single action and following that action to its subsequently induced actions and so forth. Even an attempt to keep track of "simple" items such as "jobs created" is a laborious process that takes time away from new project development, administration, etc. Evaluation and assessment is an important part of any project and in order to continue success and progress it must be built into every effort. Understanding the necessity of this effort and making it a seamless part of the project rather than something tacked on at the end is the goal of the integrated evaluation approach.

Lastly and related to the multi-dimensional discussion above, even if time is invested in tracking jobs and investments associated with a project, the data is not necessarily valid outside its immediate context. The whole purpose of a regional strategy is to recognize the strengths,

weaknesses, opportunities and threats within the region and to develop a unique program of projects for that situation. Unless the entire program is captured in a multi-dimensional way, the data is not well aggregated to the federal level.

II. Livability Initiative Update

Ms. Kim Thurlow, Project Manager for the New River Valley Livability Initiative, presented an update on the working group process and on future scenario development. Ms. Thurlow also discussed the Livability Initiative's public outreach online tool.

III. Cluster Analysis

Mr. Mecham presented on a cluster analysis that was performed the Southern Rural Development Center (SRDC) at Mississippi State University. Mr. Mecham provided the definition and associated data within a cluster analysis, highlighting the top ten sectors by employment within the New River Valley. The SRDC projected the top ten clusters to show which sectors would be creating and losing jobs in the next ten years and which clusters would be gaining or losing specialization within the region.

IV. Large Group Discussion

The CEDS Committee and Economic Development Working Group followed the cluster analysis presentation by discussing the information presented. The Committee discussed the need to further analyze what factored into the income levels in each sector, especially transportation equipment manufacturing and biomedical. The Committee also discussed the value of what this analysis could do in influencing where money should be spent, where sectors could be influenced, and what success could look like in the future.

As part of this discussion, workforce development opportunities were also discussed so that the region's workforce could be prepared for these jobs in the future. The K-12 school system was also

discussed and the Committee talked about benchmarking our schools against other schools in Lynchburg, Greensboro, or Petersburg for example. These cities have been successful in including workforce development into the K-12 system.

It was noted by Mr. Sheffey that if the localities and other agencies contributed more funding, that local funding money can help get more grant resources directed to the region. Mr. Patton asked if there will be more recommendations in the full written report. He also asked if Mr. Youngquist had any insights into how to accomplish some of the suggested changes. Mr. Youngquist responded that he felt one important change would be to have the board in more of a committee structure and then those committees would serve as advisory boards to both staff and the localities. Mrs. Lesko pointed out that the working groups within the Livability Initiative currently work in a committee structure and that we may not want to over utilize the same people repeatedly. She added that local youth be engaged in some of the committees. Mr. Sullivan asked in what time frame other PDC's accomplish these proposed changes or actions. Mr. Youngquist replied that most changes are ongoing. Mr. Sheffey pointed out that the NRVPDC is different from most PDC's in that we have two major universities, which is important for future visioning. VIII. EXECUTIVE DIRECTOR'S REPORT

Mr. Byrd provided a report in the Commission agenda packet. He reported: The MPO officially expanded to include the City of Radford and the eastern portion of Pulaski County. He also reported VDOT will hold a public hearing Thursday, October 11, 2012 from 5 – 7 p.m. at the Virginia Tech Corporate Research Center 1715 Pratt Drive, Building Number 12, Suite 1500 Blacksburg, VA 24060 on the improvements at Research Center Drive Intersection. It was also mentioned an editorial in the Roanoke Times Wednesday September 26, 2012 discussed a proposed change in the state funding formula for transit agencies. The Annual Planning Commissioner Dinner will be held on October 25th, the host locality, Pulaski County sent out invitations this week. The PDC has submitted a local stormwater program development grant on behalf of Montgomery, Floyd, and Pulaski Counties, a decision on the grant should be made by mid-October. Mr. Byrd noted that he attended the Rural Summit of Virginia and the dedication of the Rocky Knob property in Floyd County. He also reported the Department of Housing and Community Development will be contacting the Commissioners regarding PDC boundary study. Mr. Cox asked, how often does this happen? Mr. Byrd replied every ten years.

X. NEW BUSINESS

A. New River Valley Livability Project Update, presentation by staff

Ms. Thurlow began by overviewing the process of the Livability project to date. The Livability Initiative is a three year regional planning process with nine topic areas, fifteen consortium partners and seven working groups. The working group process is to identify issues, identify baseline conditions, identify common trends and projections, prioritize goals and indicators, and finally to create strategies. To date there have been 160 participants in the monthly working groups.

Ms. Davis presented on the outreach done by the Livability Initiative. The different types of outreach have been a kick-off summit, on-line and paper surveys, a Spanish language survey, a lower literacy paper survey, small focus group and community meetings, an interactive performance, digital storytelling, and the BUILT planning game. Ms. Davis also touched on some of the reoccurring comments from all outreach methods being community values, innovation, self-sufficiency, preservation, independence, self-reliance, and sustainability.

Next, several staff members presented on the individual working groups. Ms. Thurlow talked about how our population is aging and what this means for our region. She noted several concerns are a declining tax base, an increased need for supportive services, different housing and transportation needs, concerns with existing housing, and the need for new construction. She then discussed agriculture shifts within our region. She noted that all localities with the exception of Floyd County increases have had a slight decline or held steady in the average market value of agricultural products. Mr. Sharp talked about findings within the transportation working group. He reported the priorities identified to date are, to create choices for commuters, create solutions for those who don't have a vehicle or driver's license, improve accessibility to local businesses and enhance abilities to move freight, create safe and attractive places for walking and biking, and to improve access to important regional corridors. Ms. Wilsie talked about the findings within the housing working group. She explained the housing demand our region faces and noted that there will be a demand for 10,000 new homes in the next twenty years while 14,000 homes will need rehab or replacement. Mr. Mecham overviewed findings from the economic development working group; he explained connections between jobs and education levels and discussed the job losses and creation in our region for the last five years. Lastly, Ms. Davis talked about some of the health challenges our region faces and the impacts it has on the entire community.

Ms. Thurlow then explained the intersections within the working groups and talked about the value of the Livability Initiative. She explained how the data collected will help to prioritize citizen needs and preferences, how understanding trends will help recognize challenges that will be easier and cheaper to address now rather than down the road and she talked about some of the partnerships that are forming.

Discussion: Mr. Patton thanked the staff and noted they gave a great presentation. Mr. Law asked about health issues, diabetes was mentioned but what about cancer numbers for our region? Ms. Davis noted that cancer and heart disease are the leading causes of death in the NRV. Mr. Patton also noted cancer and heart disease need to be main concerns. Ms. Thurlow explained the numbers of cancer and heart disease cases in the NRV are higher than the state average. Mr. Law mentioned that he was told Giles County has a higher cancer rate than anywhere in the state. Mr. Cox noted that drug abuse and other drug related problems are also an immediate concern for our region and they need to be a priority. Mrs. Lesko noted the drug problem is multi-generational. At this point the discussion was tabled and it was decided to discuss it further at a later meeting.

VII. EXECUTIVE DIRECTOR'S REPORT

Mr. Byrd provided a report in the Commission agenda packet. He reported: ARC Co-Chair, Earl Gohl and ARC Chief of Staff, Guy Land visited October 25th, they discussed VA Community Capital Funding, the Livability Initiative, and the Crooked Road, and they also attended the annual dinner. Mr. Patton noted that he made a great connection by meeting both gentlemen at the annual dinner. Mr. Byrd also reported that the stormwater program was discussed at a local government managers meeting. Delegate Rush and Delegate Yost are working on legislation to postpone implementation of the stormwater program by local governments until July 2015 to ensure localities are ready and the building community is aware of the changes. Floyd County was awarded a CDBG Grant to Revitalize the Newtown Neighborhood, with the PDC and the Town of Blacksburg managing the project. He also reported Tommi Godwin resigned from her position with the Commission; she will be returning to her home state, Minnesota, where she will serve as an Associate Planner with the Washington County Department of Public Health and Environment.

A. Planning District Commission Assessment Rate for FY14

Mr. Patton explained that the Executive Committee is recommending maintaining the current rate this year (\$1.25 per capita); however, they do not want to go multiple years without raising the rate in order to keep up with costs. The rate is based on census population figures at \$1.25 per capita for the member jurisdictions and universities. Mr. Patton asked, "If the rate is based on population, how are Radford University's and Virginia Tech's rates figured?" Mr. Byrd answered; "The per capita numbers for universities are based on the number of students living on campus." Dr. Harvey noted that it should be put in writing that the PDC is not asking for an increase. Mr. Byrd explained the per capita assessment is in the annual Joint Budget Review Request sent to all four counties and the City with budget detail included. Further, the PDC sends letters to each town and university informing them of the upcoming fiscal year assessment rate obligation. The Joint Budget Request is due at the end of December each year and letters are sent to towns and universities in February. Mr. Nicholson pointed out that it is important for each community to know the rate is per capita. Mr. Patton asked if the population numbers are based on the census, if so are they only updated every ten years. Mr. Byrd replied, yes the population numbers are updated every ten years. He also explained some PDCs use Weldon Cooper Annual Estimates to capture population changes

on a more regular basis and suggest this is an item the Commission may wish to discuss at a future date.

Motion: Mr. Patton moved to maintain the current rate. Mr. Sullivan seconded the motion.

Action: Motion carried unanimously.

F. Review of Audit for FY12

Mr. Byrd provided an overview of the FY12 Audit prepared by Robinson, Farmer, Cox Associates. He explained the audit was performed with additional measurements this year due to increased federal funds moving through the budget. This is primarily attributed to the Transportation Equipment Manufacturers Competitiveness Initiative (TEMCI) and the NRV Livability Initiative project. The auditor not only reviewed financial performance, but also reviewed program reports submitted to funders and found activities aligned with financial accounting. The audit included a positive finding, "It is noted that the auditee has made great strides in posting year-end adjustments and is gaining a good understanding of the year-end audit process."

Discussion: Dr. Warren noted 100,000 gallons a day sounds like a lot of water and asked where the treated water ends up. Mr. Byrd explained it would ultimately end up in the New River. Mr. Via explained 100,000 gallons a day is the capability of the facility.

3. Environmental Impact Review: Radford University - College of Humanities and Behavioral Sciences

Discussion: Mr. Alvarez gave an overview of what the building will house and where it will be located on campus. He explained this building would bring faculty in Humanities into one building opposed to the current arrangement of multiple small buildings across campus. He also noted the review is for the environmental impact and funding for the building is still to be determined.

Motion: Mr. Sullivan moved for the approval. Mr. Soileau seconded the motion. Action: Motion carried unanimously, two abstentions, Mr. Via and Mr. Alvarez.

VII. EXECUTIVE DIRECTOR'S REPORT

Mr. Byrd provided a report in the Commission agenda packet. He reported: All four travel plans the PDC staff provided support to develop for Safe Routes to School in the region received invitations from VDOT to apply for funding. Schools include Belview Elementary, Auburn campus, Christiansburg Primary and Elementary School in Montgomery County, and Macy McClaugherty Elementary in Pearisburg. Giles County and Pearisburg received funding to improve two boat ramps; he explained PDC staff worked with the two communities to prepare the applications. Mr. Cox noted, the City of Radford has six miles of river frontage and two boat ramps in need of repairs. He mentioned the City may be interested in working with staff next year repairing or replacing these boat ramps. Mr. Sullivan asked, "How much does a boat ramp

cost?" Mr. Sharp explained the grants applied for were up to \$100,000.00. Mr. Byrd noted a memorandum was sent to all local governments inquiring about technical assistance projects for FY14, there has been interest from Pulaski County, and the Towns of Christiansburg, Narrows, and Pulaski. The NRV Livability Initiative recently completed a Community Priority Survey; the results were included in the packet. Mr. Cox explained that he would like to see the results from Radford. Mr. Byrd reported that the Planning Commissions for Montgomery County, Blacksburg and Christiansburg asked the Commission to provide an update on the NRV Livability Initiative and to facilitate a BUILT NRV planning game with the group. He reported the PDC is considering submitting a Letter of Intent to a grant program offered through the Virginia Board for People with Disabilities and asked if anyone had any objections. Mr. Garrett asked, if this information was currently available and if the project would be statewide. Mr. Byrd replied, that it is not currently available and that the final product, a training module, would be available on a state wide basis. He gave an update on the stormwater project. He reported Delegate Rush introduced legislation to postpone implementation of local stormwater programs until July 2015. Lastly he reported the PDC roadshow is continuing, Montgomery County and Giles County still need to be scheduled.

VIII. OLD BUSINESS

A. Review and Discuss Agency Assessment

Mr. Patton asked each of the commissioners if they felt they had enough time during the last meeting to prioritize the goals. Everyone replied they did feel they had enough time. Mr. Sullivan asked if there are things missing from the recommendations. Mr. Garrett noted he understood the purpose of the assessment was to set a direction for the Commissioners rather than be a philosophy for the staff. He also noted that while he still agreed with the top five prioritized goals he would not want to restrict the committee too much and he would like to hear their suggestions. All Commissioners agreed and Mr. Sullivan explained they would report back to the Commission verbally with what they plan to put into action.

IX. NEW BUSINESS

A. Transportation Program Updates

Mr. Sharp gave an overview of the Governor's Transportation Plan. He noted there are six main parts to the plan. The six parts are; replace the 17.5 cents/gallon tax with a .8% increase in state sales tax (diesel tax remains the same), increase existing sales tax commitment from .5% to .75% over 5 years, \$15 increase in registration fees, \$100 alternative fuel vehicle fee, market place equity-transportation, and market place equity-local transportation. Mr. Chambers stated that he thinks all people who drive thru Virginia should be taxed and that alternative fuel vehicles should not be additionally taxed. Mr. Garrett noted that it doesn't change the charges on people it only changes where the charges are made.

B. Review Key Legislative Items

Mr. Byrd explained that a list of the VML and VACo legislative priorities was included in the packet. He asked if anyone had any other priorities they would like presented. Mr. Clevinger expressed interest in teachers and other local government employees being able to participate in the state healthcare system.

X. OTHER BUSINESS

Mr. Patton explained that next month's regional focus will be tourism and economic development. He also noted that a guest has been invited from Roanoke Convention & Visitors Bureau.

XI. REGIONAL FOCUS

A. Overview of PDC Financial Operations

Mr. Byrd gave an overview of the financial operations. He explained each of the accounts operated by the PDC and gave the balances of each. PDC is a reimbursement business, which keeps enough operating cash for 6 months of payroll liability. He noted the PDC budget is fluid throughout year and operations are different from local government financial operation. He then explained how the budget is created each year and how the revenue is generated, followed by the PDC's matching obligations and expenses. Mr. Byrd also explained the cost allocation plan. He noted the PDC must be entrepreneurial and noted the average investment ratio for members is 9:1.

The meeting was then adjourned at 7:50 pm.

He also mentioned that if a Commissioner is not able to make it to the meeting please let PDC staff know with as much advance notice as possible.

Discussion: Mr. Law indicated the public notice for the project states the facility will release treated sewage into Little Stony Creek which terminates at the New River; he noted that Little Stony Creek sinks into karst and does not flow over land into the river.

He recommended this information be considered by DEQ and reevaluate permit conditions.

Motion: Mr. Law moved for the approval with recommendation to DEQ. Ms.

Newcomb seconded the motion.

Action: Motion passed unanimously.

2. INGENCO Renewable Development major source construction permit – construction of a landfill gas to electricity generating facility.

Motion: Mr. Clevinger moved for the approval. Ms. Newcomb seconded the motion.

Action: Motion carried unanimously.

VIII. EXECUTIVE DIRECTOR'S REPORT

Mr. Byrd provided a report in the Commission agenda packet. He reported: The PDC is assisting the Town of Blacksburg in a staffing capacity role for the HOME Consortium. He also spoke about the requests for technical assistance from members and noted a list of the localities that had contacted the PDC was provided in his report. The NRV Tourism website Committee met in February and expressed a desire to keep the website active. The Commission will cover the cost of website hosting for another year (approx. \$150.00). Mr. Sullivan asked, "Who provides the updates to the website, is it automatic?" Mr. Byrd explained the event section of the website is locally driven and is updated by either the chambers or a designated tourism person, but noted the committee is working with Citizens Cooperative (website designers) about automatic updates from Virginia Tourism Corporation.

Mr. Byrd made note of the PDC's new letterhead and business cards which provide a fresh look for the Commission. He will be attending an annual conference for ARC and NADO in DC mid-March. While there he will visit members of Congress representing Virginia. Mr. Byrd explained he was among a small group of directors across the country invited to attend a session hosted by the Ford Foundation on Rural Wealth Creation which will teach how to maximize local assets.

He also talked about figures Round the Mountain shared from income derived from Heartwood, there was \$250,000 income in 2012, 26% of which was from the NRV. He also spoke about the management and budget for Heartwood. Mr. Sullivan asked, "How is Heartwood doing?" Mr. Byrd replied, it is a work in progress to launch and operate such a unique facility. Some aspects are doing well and other aspects are changing based on learning experiences. Mr. Nicholson asked, "How many artisans are from the NRV?" Mr. Byrd replied the number of artisans by

county that are members in RTM and have juried into Heartwood can be obtained and will provide next month.

Mr. Byrd explained he had received news from Aric Bopp at the NRV Economic Alliance that there is concern the Port of Entry at the NRV Airport may close due the retirement of staff. There will be a meeting March 6th at 3:00 pm at the Airport to discuss what this may look like. Mr. Nicholson asked, "Will it be a public meeting?" Mr. Byrd replied, "Yes." Mr. Garrett noted that if the facility is not economically viable, there needs to be a campaign to double the traffic to make economic sense to keep the port. Mr. Byrd noted cost sharing for companies using the airport might be an idea. Dr. Warren explained in the past the NRV Airport had outperformed neighboring airports. Mr. Patton asked if we need to draft a letter expressing the need for this port in the NRV. Ms. Newcomb expressed concern needs to be strongly placed. Mr. Nicholson pointed out that this will have an impact on corporations in our area. Ms. Janney expressed a need to be forceful and support this important infrastructure in the NRV. Mr. Cox talked about the significance of the airport working with the Alliance and how the port helps attract businesses. It was decided that after the meeting on March 6th a resolution may be drafted for the Commission to consider at their meeting on March 28th, or if the issue is time sensitive, the Commission directed Mr. Byrd to draft a letter of support for the Port.

IX. OLD BUSINESS

A. Update from Agency Assessment Committee

Mr. Sullivan overviewed the preliminary report included in the packet. He noted the committee was made up of Mr. Chambers, Mr. Cox, Dr. Harvey, Mr. Law, and Mr. Nicholson. He explained the committee wanted to start with the recommendations that are already being implemented and explained the order or priority ranking does not mean one item is more important than another, it means the item will be able to be implemented faster. Mr. Sullivan gave a brief summary of each of the eight recommendations and then discussion followed. Mr. Garrett noted that one of the recommendations is to ensure each board member is providing a copy of the minutes to their locality, he noted after the minutes are approved they are six to eight weeks old. He suggested draft minutes be sent to board members by email (if available) within a few days of the meeting. Ms. Janney questioned the recommendation to change the annual dinner to an annual summit; she wanted further information on why it should be changed. Mr. Sullivan explained changing the dinner to a summit would create a learning session in the afternoon which would be attended by members of local planning commissions and a leadership session in the evening which would be attended by local and state leaders. Mr. Garret asked if October is the best time of year to host this type of event. Ms. Perkins explained how important it is to have top elected leaders who will attend the recommended Regional Mayors and Chairs meetings to communicate information back to their fellow elected officials. It was suggested that a summary of those meetings be distributed as well. Ms. Newcomb asked if the committee wants feedback tonight. Mr. Sullivan responded that the intention of the preliminary report is to give the Commissioners time to read over the recommendations and they can email feedback to Mr. Byrd which will then be forwarded to the committee. Dr. Warren noted another board he sits on emails a summary of the meeting to members within a few days of the meeting. It was decided a draft copy of the minutes will be sent out to board members and local government managers after each meeting in order to increase communication between the PDC and members.

X. NEW BUSINESS

A. Rural Transportation Work Plan for FY13-14

Mr. Sharp gave a presentation on the Rural Transportation Work Plan. He began with explaining what the Rural Transportation Work Plan is, he explained the plan includes State Planning & Research Funds, it is administered by VDOT, it is intended for non-urbanized areas or areas outside of the MPO, and it requires 20% local match. Mr. Sharp explained tasks associated with the plan, project budget, and gave an example of a local project. He explained the Route 99 Retail Feasibility Study in the Town of Pulaski is an ongoing local project. Some of the tasks associated with this project are to identify potential economic development opportunities for the Town of Pulaski, to identify sites for redevelopment and sites for new development, to evaluate transportation enhancements, and to develop conceptual scenario plans. He then overviewed maps of the area to explain the opportunities for the Town. Mr. Sharp talked about the grant writing portion of the plan and how it is used to help localities identify funding for specific projects. Mr. Sharp explained there are 15 to 30 statewide transportation plans that are updated on a regular basis.

Motion: Ms. Perkins moved to adopt the resolution of support for FY2014 Transportation Planning Work Program. Mr. Cox seconded the motion.

Action: Motion carried unanimously.

B. Community Development Block Grant Priorities for FY13-14

Mr. Byrd overviewed a memo in the packet for FY13-14 pertaining to CDBG Priorities. He pointed out it is important to have all identified projects listed.

XI. REGIONAL FOCUS

A. Overview of Managing a Planning District Commission.

Mr. Byrd gave an overview of managing the PDC. He started with reviewing the recommendations he presented at his interview for the Executive Director position with the PDC in August 2009. He talked about focusing on internal successes and how those

will transition to external successes. He noted the importance of setting individual staff as well as agency wide goals, building a tenured staff, attending member government meetings as well as sitting down with Town/City Managers and County Administrators, and creating a budget along with financial preparedness. Mr. Byrd explained the PDC has seen advances in the internal side and we are now seeing increased relationships and increases on the quality of service. He overviewed short and long range goals for the PDC. He discussed the need for a new focus on direction, operation issues and the technology plan in place. He also talked about the financial oversight and how the GMS software allows project oversight. He noted the personnel focus on retaining employees is being met by improved personnel policies that offer flexibility, by empowering employees within their projects, and by engaging employees in decisions. He explained the responsibilities he has to the board including, meeting with the Executive Committee in advance of the meeting, prep work in getting the packet together as well as other business items such as program topics or speakers. He also has individual projects and advises staff in their project management roles. He explained how new project ideas are often presented to him and how he works on the front-end of projects to figure out scope, assign to staff, create a budget, then transition to staff after funded. Mr. Byrd talked about the importance of relationships and how it is important that our communities know we understand what they are doing at a certain time, this requires a lot of "out of office" time in meetings, speaking to groups, events and one-on-one appointments. He also noted relationships with organizations such as VAPDC, SERDI, ARC, and NADO are important to bring new ideas and solutions to the region. He talked about what is on the horizon for the organization and the need for a strategic plan and encouraged the board to take the lead on topics facing the region. Finally he mentioned the need for a staffing structure in order for the agency to continue on its performance trajectory and the ability to staff correctly so the Commission can address future needs in communities across the region. Mr. Garrett asked, "What are ages and experiences with in the PDC and are they far enough apart?" Mr. Byrd replied there are two people with over 20 years of service and several with 10 to 15 years so the agency is pretty balanced. Mr. Sullivan asked, "How long does it take to train a new hire?" Mr. Byrd replied about one to two years to learn the region and to be effective. Ms. Perkins commended Mr. Byrd making the Commission meetings worthwhile, for working with the staff to complete projects and accomplish fantastic things with in our communities, and for great leadership skills. Mr. Bopp noted that the board has good members.

Mr. Patton called for a motion to adjourn the meeting.

Mr. Patton called for approval of the consent agenda item if there were no questions or changes.

Motion: Mr. Sullivan moved for the approval of the minutes. Mr. Garrett seconded the motion.

Action: Motion carried unanimously.

M. Approval of Treasurer's Report for February

Mr. Patton called for approval of the consent agenda item if there were no questions or changes.

Motion: Ms. Newcomb moved for the approval of the treasurer's report. Mr. Soileau seconded the motion.

Action: Motion carried unanimously.

III. REVIEW OF MUTUAL CONCERNS AND COMMISIONERS' REPORTS

Mr. Cox noted a steam excursion train stopped in the City of Radford March 9th and brought over 500 passengers into the City. The train was well received and the gentleman who runs the

excursion program noted in the past he has never had a community set up and be as proactive in providing services to the passengers as was done in the City of Radford. Mr. Showalter also noted the Town of Christiansburg hosted a swim and dive meet at the Aquatic Center which attracted thousands of people. He also showed the memorabilia the Town of Christiansburg contributed to the PDC for their office entrance.

IV. EXECUTIVE COMMITTEE REPORT

Mr. Sullivan gave an overview of the discussion held at the Executive Committee meeting. The committee discussed the health insurance plan options for staff and ways to keep costs in control. The committee also discussed the staffing structure and a possible partnership with The Community Foundation to continue the Livability Initiative after the grant is complete in January 2014.

V. CHAIR'S REPORT

Mr. Patton noted the draft minutes for February had been sent out early and asked if all Commissioners received them, he explained this will continue and the turnaround will be within one week. He also explained the details of the possible Port of Entry closure at the NRV Airport. He explained how much a Port is expected to do annually to stay operational; the expectation is an average of 2,400 transactions. The port at the NRV Airport has an average of 94 transactions; however, the way pieces are counted has changed which does not clearly reflect actual volume for the area. He noted that we need to be supportive of the Port and keeping this economic development resource available to businesses in the New River Valley and beyond. The Commission will consider submitting a letter of support for the Port once more information is obtained from the NRV Economic Development Alliance, which requested data from the US Department of Homeland Security a couple of weeks ago. He also noted what a great job the Commission is doing serving the New River Valley.

VI. REGIONAL FOCUS

A. Roanoke Convention & Visitors Bureau Overview.

Mr. Landon Howard from the Roanoke Convention & Visitors Bureau gave a presentation and explained what a CVB is and what they do in terms of tourism infrastructure. Before beginning, Mr. Sullivan noted what the Roanoke CVB, along with Mr. Howard, is doing and how it includes more than just the Roanoke area. Mr. Howard explained a CVB is the regions' destination market organization and their job is to define the consumer brand and build an image for the area. The CVB acts as an information broker between the businesses and consumers. They focus on community, consumers, and competition to define a brand identity for the area. Mr. Howard explained the target audience for the area, along with the interests of visitors and the reasons they visit the area. He noted the most recognized brand for the Roanoke area internationally is the Blue Ridge Mountains and nationally it is

Virginia Tech. He explained the Roanoke CVB is using the name Virginia's Blue Ridge to define the region. He went on to discuss how the Virginia Vacation Guide contains very limited promotion of the mountains and the need for all of western Virginia to work together on this issue extending from the Shenandoah Valley down to far southwest. Mr. Patton asked, "Who publishes the Virginia Vacation Guide?" Mr. Howard replied, "It is published by the state." Dr. Harvey asked, "If ideas related to Virginia Tech being a nationally recognized brand are positive or negative?" Mr. Howard explained all comments he has received have been positive. Ms. Newcomb asked, "What will be necessary to make the Virginia mountain region happen and be recognizable?" Mr. Howard explained the CVB is currently working with other areas to see who is interested in working together; he also noted how an area can be marketed individually within a region depending on the needs. Mr. Sullivan asked, "Why do most tourist come to our area?" Mr. Howard replied most visitors come for outdoor activities, while some visit Roanoke for restaurants and the symphony. Mr. Howard explained visitors to the area do not see boundaries; they stay in both Roanoke and in the NRV. Mr. Sullivan asked, "How is the CVB funded?" Mr. Howard replied they are currently funded through a lodging tax agreement with local governments in their area as well as business members outside of the participating localities. Mr. Sullivan also inquired if anyone could join the Roanoke CVB. Mr. Howard indicated businesses outside of the member local governments could pay to be members and receive benefits from the CVB. Mr. Patton then thanked Mr. Howard for giving the presentation and asked Ms. Bleakly from Montgomery County Tourism Development Council if she had any additional comments. Ms. Bleakly noted she is in the final stages of completing the Tourism Strategic Plan for Montgomery County, Blacksburg and Christiansburg. During the plan development process it appears there are opportunities where Montgomery County can work with Roanoke CVB and still have their own identity and have a unique local brand when it makes sense to do so.

VII. EXECUTIVE DIRECTOR'S REPORT

Mr. Byrd provided a report in the Commission agenda packet. He reported: The PDC staff coordinated with the MPO and Virginia Tech to host a meeting with two Commonwealth Transportation Board members to take a closer look at two projects, the Multi-Modal Facility at VT and the Southgate Drive Interchange Project. It was also noted the PDC is preparing a Bike and Pedestrian Master Plan for the MPO.

The Town of Narrows and Taylor Hollow Construction held an open house to showcase a project in downtown Narrows which consisted of renovation of a downtown building with the lower floor being leased to the Town for their town hall and the upstairs was converted to affordable housing. The housing portion of the project utilized funds from the NRV HOME Consortium. Mr. Garrett stated how important it is for a small town to have to have businesses downtown, he notes they now have a grocery store and a bank and are hoping to have more businesses on Main Street.

Mr. Byrd also reported the NRV Commerce Park secured their first tenant, Red Sun Farms. They will be investing \$30 million and create over 200 jobs in five years. He also explained due to impacts from sequestration, the PDC will be receiving a \$10,000 reduction in economic development planning funds from EDA for FY14.

Mr. Byrd explained the Livability Initiative's interactive community survey, CrowdGauge, will launch in April and gave a list of open houses in the area to provide people without internet access so they can have an opportunity to share their priorities. He also announced the annual Planning Commissioner's training will be held May 15th at the NRV Business Center. Mr. Patton explained that he will be present for the Planning Commissioners Training and he wants other Commissioners to join him. Mr. Byrd noted the PDC will be working with Pulaski County and the Town of Pulaski to provide technical assistance to identify whether the two governments could work together collecting tax revenue, he explained the PDC will not offer any recommendations and only provide a report to both localities. He also reported a handout with the NRV sales at Heartwood was distributed, it shows what the average artisan revenue from items at Heartwood.

VIII. OLD BUSINESS

A. Recommendations from the Agency Assessment Committee

Mr. Sullivan explained the final report was included in the packet and noted an additional comment was received from Ms. Janney concerning the change in the annual dinner. The comment from Ms. Janney was as follows; "Floyd County members strongly disagree and are opposed to changing the time for this meeting. The dinner is not the subject but the time is. Our members are working public jobs in the afternoon. It is not always possible to take time off from work and be able to keep a job. They do value the opportunity they currently have being able to share with the other counties. I thought the elected officials should be meeting with their constituents and have been included in our meetings." Mr. Garrett noted the dinner in the past has focused on local Planning Commissioners and asked if they will continue to be invited as they are not listed on the target audience in the recommendation. Mr. Sullivan replied, "Yes they will be included, the intent is to have more of a training session in the afternoon and a gathering of the region in the evening rather that a dinner where each locality would present." Mr. Gerald noted how in the past each community has given a report and he would like that to continue. Mr. Sullivan explained that the intent is to change the event but not to exclude. Ms. Lesko noted that if the target audience is too large it will be hard to find a space to accommodate everyone and noted that it changes the dynamic to include everyone. Mr. Patton noted that it does change; however, it does not mean that anyone will be left out and it will make the entire event better overall.

Motion: Mr. Sullivan moved to approve the recommendation of accepting the Agency Assessment Subcommittee report as presented. Ms. Newcomb seconded the motion.

Mr. Patton began implementing the Agency Assessment Committee's report as follows; item one, Mayors and Chairs meeting, Mr. Byrd will identify a date for the first meeting to take place in the new fiscal year. Item two: Mr. Patton named himself and Dr. Harvey as cochairs for the NRV Annual Summit, the committee will be determined at another date. Item six, Conduct Fact-Finding Field Visits: Mr. Patton named a committee to report back to the Commission with a complete recommendation as soon as possible. The committee will be Mr. Clevenger, Chair, along with Mr. Garrett, Ms. Perkins, and Mr. Soileau. Item seven, GIS services: There will be a task force comprised of people outside of the Commission; the Chair will be Ms. Lesko.

A. Review CEDS Goals, Objectives, and Ranking Criteria

Mr. Mecham gave a presentation on the CEDS Goals, Objectives, and Ranking Criteria. He explained the CEDS is done every year and is sent to the Economic Development Administration (EDA) to identify projects that will benefit the region. He noted the reason the CEDS is done is to qualify projects for EDA funding and provide vision for the regions' economic future. He gave some examples of projects that received EDA funds because they were identified in the CEDS such as, the Corporate Research Center at VT, local hospitals, and most recently a multi-tenant business building within the Floyd County Commerce Park. Mr. Mecham explained the CEDS is created by the CEDS committee and noted that by law there is 51% or more private sector representation. He then overviewed some of the surveys used to determine the needs of the area. The Workforce Investment Board provided a Skills Gap survey which identified the top five soft skills and top seven technical skills needed by employers. The cluster analysis also identified some of the strong economic sectors of the region. The Livability Initiative Community Priority Survey helped identify goals, objectives & strategies by locality. He then explained the goals this year are condensed into seven key areas and the ranking structure for the CEDS is proposed to remain unchanged.

Discussion: Mr. Sullivan asked if the concern or problem of individuals not passing drug testing has come up. Mr. Mecham explained that it is a problem and noted one industry on the CEDS committee brought a different perspective to the committee this by explaining they eliminate 50-60% of applicants because of reading comprehension skills. Ms. Newcomb expressed that this is a problem that needs to be brought to the local school boards attention. Mr. Mecham noted there are two school systems with representatives on the CEDS committee. Mr. Patton asked if each locality is represented on the CEDS committee. Mr. Mecham noted the committee could use more representation from Giles County. Mr. Sullivan expressed a need for the Commission to promote awareness of the NRV and explained this board can be a bridge for our region.

Mr. Patton shared an article that was published in Antique Week, which is a national publication, featuring an auction which Mr. Clevinger served as a coin appraiser.

V. EXECUTIVE COMMITTEE REPORT/CHAIR'S REPORT

Mr. Patton welcomed Mr. Carpenter, the Commission's representative from Radford University. Mr. Patton called for the Commission to adopt a resolution of appreciation for Mr. Alvarez, the previous representative from Radford University.

Mr. Patton also welcomed Mr. Vanhoozier, who attended the meeting in Mr. Showalter's place for the Town of Christiansburg. Mr. Patton gave an overview of the discussion at the Executive Committee meeting. At the April meeting the committee primarily discussed next year's budget and the impact of sequestration. He explained they also discussed the staff position at the Port of Entry in Dublin and noted a letter of support has been sent to U.S. Customs and Border Protection. Lastly, Mr. Patton announced the VAPDC conference this summer will be held July 25-27 and explained the commission can send 3 additional board members. Also, the annual Planning Commissioner training event will be May 15th at the NRV Business Center and board members are encouraged to attend.

VII. NEW BUSINESS

A. Regional Transit Coordinating Council Future Meeting Schedule

Mr. Byrd noted a memo was included in the packet. He also noted the feedback received from the group has been positive and the meetings were valuable to the participants. As the memo indicates, the Transit Coordinating Council would like to continue their efforts for another two years.

Mr. Patton called for the Commission to approve the request from the Transit Coordinating Council by extending the meetings for another two years.

Motion: Ms. Lesko moved for the approval. Dr. Warren seconded the motion.

Action: Motion carried, one abstention, Mr. Vanhoozier.

B. Review CEDS Project List

Mr. Mecham gave an overview of the CEDS project list for this year. He explained projects are identified by local governments in the region and the CEDS committee. He noted that of the projects listed, eleven are complete and fifteen have been funded or are currently underway. He also noted that total funding for the completed or underway projects in the region is \$107,000,000.

Discussion: Ms. Lesko asked, "Why do projects that are ranked the highest not have dedicated responsible agencies?" Mr. Byrd replied, "They are ranked on project readiness and if it is lacking responsible agents or partners it is something that can be lacking but the project has been identified by the CEDS committee or others as a project of value." Dr. Warren noted that on the handout provided at the meeting the project names Skyview Subdivision/Fairgrounds Area Sewer should not include Fairgrounds Area since that was reduced from the scope of work. Dr. Warren also noted the Fairgrounds still needs sewer improvements.

VIII. EXECUTIVE DIRECTOR'S REPORT

Mr. Byrd provided a report in the Commission agenda packet. He further reported on the following: The Southwest Creative Economy Conference will be held September 19-20 in Abingdon and noted a new effort "Appalachian Spring" will be highlighted at this conference. The PDC is facilitating a brokerage agreement between four public utility providers, Peppers Ferry Wastewater Treatment, Pulaski County PSA, Blacksburg-Christiansburg-VPI Water Authority and Montgomery County PSA, for the purposes of a utility conduit under the Rt. 114 Bridge. The public utility providers, which are parties to an agreement with the PDC for the utility conduit, are currently in discussions with their respective boards about participation in the project. Mr. Byrd

explained the Livability Initiative is currently conducting NRV Tomorrow survey outreach meetings, with an average of 10 or 15 people attending each meeting. He noted the letter that went out in support of the Port of Entry was based on a template the alliance put together and stated if any local government would like the template he will provide it to them. The New River Symposium, an annual meeting focusing on the watershed from NC to WV, will be held May 30-31 at Radford University and 3 PDC staff members will highlight recent work at the Commission. He noted two staff members were invited, and attended, a conference in South Carolina to present their work based on the value their approaches would bring to other regions of the country. The memorabilia from Commission members is almost complete and at the next meeting in May the Commission will be invited to walk down to see the entrance area to the offce. Lastly, he explained the budget will be presented a little differently this year, next year's budget will be presented in May and the revised budget will be presented in June.

IX. REGIONAL FOCUS

- A. Montgomery County, Blacksburg, Christiansburg Tourism Overview

 Ms. Lisa Bleakley, Executive Director, Montgomery County Regional Tourism Office gave a presentation and overview of the operations at the tourism office. She explained the Montgomery County Tourism Office was established in 2011 and in the fall of 2012 she was hired as the first Director. She highlighted the different tourism assets with examples from Blacksburg, Christiansburg and Montgomery County. She noted the partnerships between Blacksburg, Christiansburg and Montgomery County and the surrounding areas. She explained that it will take all localities working together to create a successful tourism program.
- B. A video on Appalachian Spring, which is a rural jobs accelerator grant program, was shown by Mr. Byrd. The video gave an overview of the different recreation assets in southwest Virginia as well as the history in the region. Mr. Byrd explained the program is about building recreation resources for the purposes of economic development and enhancing quality of life. A project administrator has been hired to focus on economic metrics. The project will look back at economic indicators from 2002, the year before The Crooked Road started, to evaluate whether any economic changes can be attributed to the creative economy. The concept right now is for this to be a sister organization to The Crooked Road and 'Round the Mountain, but for recreation. He explained this is a 3 year planning process and it will engage communities about assets they would like developed. The project will also work with Virginia Community Capital and People Inc. to develop creative lending solutions for businesses. Planning Districts will be involved by holding community meetings.
