**Re: November 2025 Financial Statements**

The November 2025 Agencywide Revenue and Expenditure Report and Balance Sheet are enclosed for your review. Financial reports are reviewed by the Executive Committee prior to inclusion in the meeting packet.

The Agencywide Revenue and Expense report compares actual year to date receipts and expenses to the FY25-26 budget adopted by the Commission at the June 26, 2025 meeting. The financial operations of the agency are somewhat fluid and projects, added and modified throughout the year, along with the high volume of Workforce program activities, impact the adopted budget. To provide clarity, Commission and Workforce Development Board activities are separated on the agencywide report.

As of month-end November 2025 (42% of the fiscal year), Commission year to date revenues are 47% and expenses are 47% of adopted budget. The two largest budget expense lines, Salary and Fringe, are in line with budget at 41% and 46%, respectively.

Looking at the balance sheet, Accounts Receivable is \$583,063. Of this total, Workforce receivables are \$197,224 (34%) and current. The Executive Committee reviews all aged receivables over 60 days and no receivables are deemed uncollectible. Net Projects (\$317,956) represent in process projects that have not been invoiced and posted to receivables.

The New River Valley Airport Commission has initiated a Comprehensive Environmental Assessment (EA) for review of various projects at the New River Valley Airport (PSK), as detailed below and depicted in the attached Exhibit. In accordance with NEPA requirements outlined in FAA Order 1050.1f, we are requesting your input on the proposed project.

The proposed project includes the realignment of a portion of the parallel taxiway, apron expansions, relocation of windsock and segmented circle, and additional hangar construction. The project will also include the addition of security fencing in the terminal area and a potential stormwater management area (as deemed necessary during the engineering design phase). The primary intention is to meet current FAA standards for runway taxiway separation alignments and remove direct connections from apron to the runway. Additionally, the project provides infrastructure that addresses capacity and constraint issues on the airfield by expanding the apron and providing additional hangar storage space. Attached is an exhibit that outlines area of potential impact with the proposed development depicted.

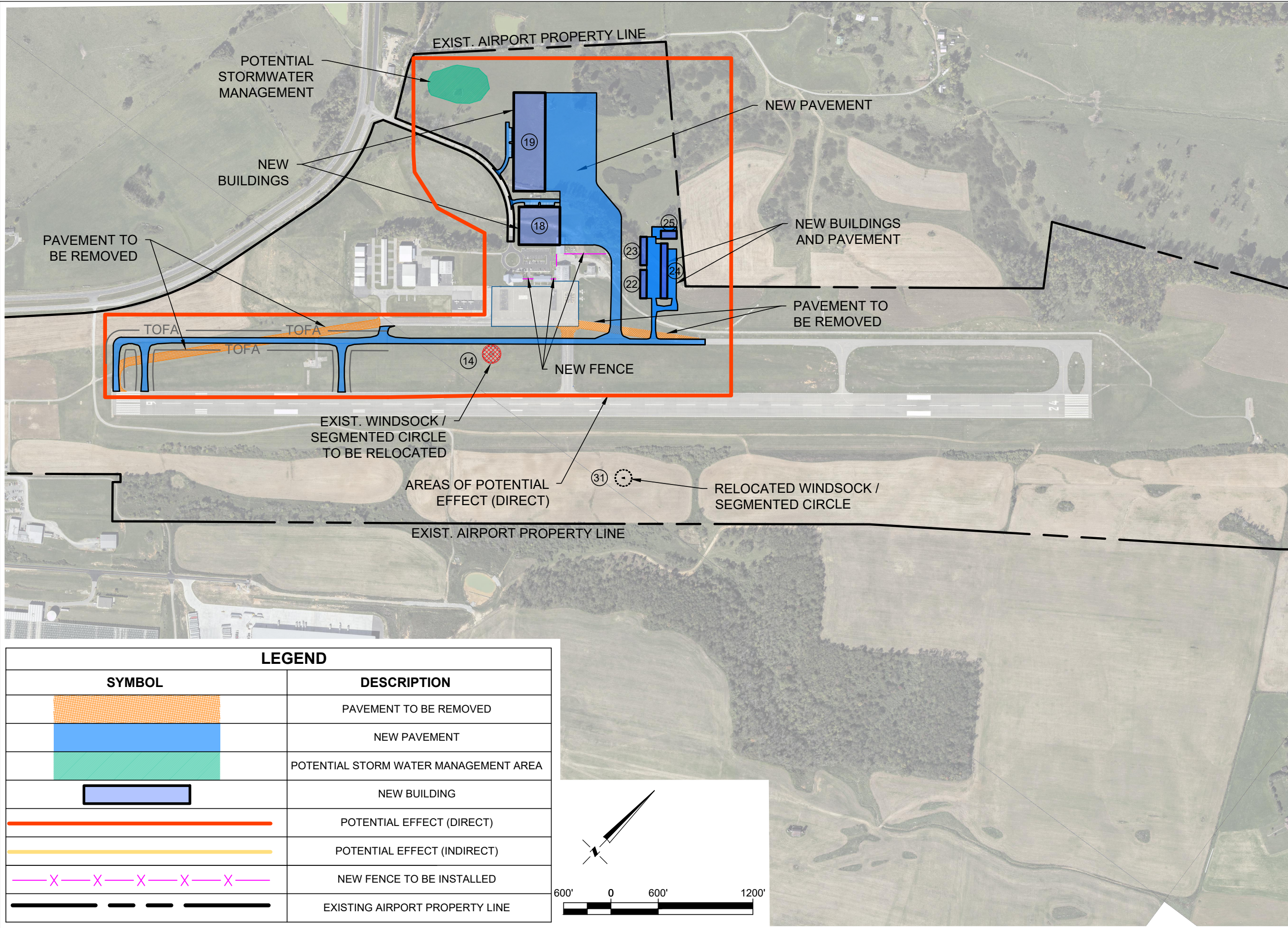

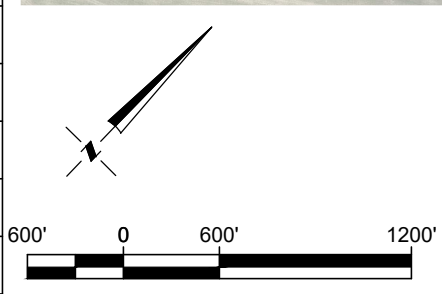

## **Executive Director's Report**

### **Economic Development:**

- The AM2 Tech Hub submitted a statewide competitive GO Virginia grant recently in partnership with neighboring GO Virginia regions. The state board for GO Virginia will hold a pitch call on February 24<sup>th</sup> as its review gets underway. The AM2 Tech Hub is working on a sizeable grant application to the US Economic Development Administration due in March in pursuit of Disaster Recovery funds for consortium-based projects. The 10-year roadmap that was prepared as a key deliverable for the Tech Hub Strategy Development Grant can be viewed [at this link](#). In November, the AM2 Tech Hub received the Chairman's Award for visionary leadership and commitment to Southern Virginia presented by the Southern Piedmont Technology Council.
- The Blue Ridge Innovation Corridor (BRIC), a coalition of business leaders supporting economic development in an emerging megaregion that extends from Danville to the New River Valley and includes Roanoke Valley, is kicking off a Vision 2050 planning process. The project is funded by GO Virginia. BRIC reached out this week inviting steering committee members to participate in the process. More about BRIC can be found [here](#).
- Governor-Elect Spanberger selected Carrie Chenery to serve as the Secretary of Commerce and Trade. The Department of Housing and Community Development falls within this secretariat position. Ms. Chenery served as a Deputy Secretary for Agriculture and Forestry in the Northam Administration and was the executive director of the Shenandoah Valley Partnership, the equivalent of Onward NRV. While she was finishing up her studies at Virginia Tech, Ms. Chenery was an intern at the Regional Commission! She helped develop the first Water Supply Plan for the region.

### **Broadband:**

- The Pulaski County broadband project is making quick construction progress now that make-ready is nearly complete. Some limited areas are already able to subscribe and connect. The county will be working with All Points Broadband to market the service through a PSA mailer soon.
- The Montgomery/Bland County VATI 2022 is approximately 90% complete with fiber construction. The 10% remaining includes splicing of fiber to reach homes and businesses. Numerous connections are already established throughout the project area with more subscribers being added regularly.

### **Transportation:**

- The NRV Passenger Rail Station Authority is meeting on January 22<sup>nd</sup> and will be receiving updated architectural plans from the consultant team. The Authority appointed an Architecture Committee at its meeting in November. The committee met twice over the past two months to offer guidance to the consultants on material selection (ie-flooring, windows, wall color) and their progress will be shared at the January meeting. The Authority will also review content for a historical marker to be placed at the building.

- Governor-Elect Spanberger selected Nick Donohue to serve as the Secretary of Transportation. Mr. Donohue has extensive experience with transportation in Virginia having served under three different governors playing key roles in developing SMART SCALE, the I-81 Corridor Improvement Program, and Transforming Rail in Virginia initiative which the NRV service extension was a key beneficiary.

#### **Housing:**

- The Regional Commission is supporting Floyd County on a planning grant for a potential housing development project. This week staff assisted with a neighborhood meeting and in two weeks they will support a community-wide meeting.
- The update to the Regional + Local Housing Study is still on target for a fourth quarter kick-off. A portion of match funds will come from the NRV Regional Commission's Recovery Ecosystem budget that will allow for information to be gathered on the unhoused population, which was not included in the previous regional housing study.

#### **Natural Resources:**

- The New River Watershed Roundtable will meet on January 27<sup>th</sup> at 9:30am. Beth Lohman with VA Dept of Environmental Quality (DEQ) Office of Pollution Response & Emergency Preparedness will speak to the group about DEQ's role in water quality, particularly around emergency situations. The Roundtable will be meeting quarterly on the 4<sup>th</sup> Tuesdays in 2026.
- The New River Water Supply Plan project was recently awarded grant funds from DEQ for the second phase of work which will focus on the Water Use Regulation. This will fund another six months of activity until DEQ opens grants for the next round. A budget amendment was submitted to the General Assembly to increase funding for Water Supply Planning activities since it is at a fraction of what it was the last time there was a substantial update required.

#### **Regional:**

- The Regional Commission continues to support communities impacted by Hurricane Helene. The Virginia Disaster Assistance Fund (VDAF) program is open for applications. Information about the program is on our website [here](#). The Regional Commission recently executed an agreement with the Dept of Conservation and Recreation Resilient Virginia funding program that will address impacted bridges, culverts, and retaining walls. Another program through the Dept of Environmental Quality is nearing an agreement which will provide \$4M for debris removal in the New River along with staffing funds to develop Debris Removal Plans for localities in the region.

#### **Commission:**

- As mentioned in November, there are staff transitions underway in the Community Health team. Holly Lesko retired this week and Anna Champion was promoted to Program Administrator. Mikhala Stafford served as an intern the past six months and recently increased duties into a part-time role while she finishes her graduate degree at Virginia Tech. There is also a position currently being advertised for Grant Management & Network Facilitator which is available on the Regional Commission [website](#).
- I'll be facilitating the Blacksburg Town Council 2026 retreat February 12<sup>th</sup> with a focus on goal setting with the new council.
- The NRVRC staff continues learning and practicing skills around the 6 Types of Working Genius, an assessment and tool created by Patrick Lincioni, that was the focal point of the staff retreat in the fall. Part of our agencywide staff meeting in January was spent revisiting the team map, reflecting on prompt questions, and group discussion on its applicability.

---

Virginia's Additive Manufacturing and Advanced Materials (AM2) Hub is a consortium of over 50 industry, higher education, local government, and organization partners, supporting advanced manufacturing through the growth and adoption of additive manufacturing and advanced materials (AM2) technologies in the Southwestern and Southern regions of Virginia.

Over the past two years, the AM2 Hub leadership team conducted a strategic development process. The process directly engaged business leaders and researchers to identify strategies and opportunities for establishing the region as a hub for additive manufacturing and advanced materials technologies. Based on these discussions and industry market research, the team developed a 10-year strategic roadmap. The primary strategies focus on business and technical assistance as well as workforce development.

Looking forward, the AM2 Hub has identified two funding opportunities to support the implementation of these strategies: (1) the Virginia Growth and Opportunity Fund (GO Virginia) Competitive Grant Program and (2) the Economic Development Administration (EDA) FY 2025 Disaster Supplemental Grant Program. The Hub has applied to the GO Virginia opportunity, with the project slated for final review by the Virginia Department of Housing and Community Development in late March. The EDA funding application is due March 3rd with review later in the year.

---

RIDE Solutions NRV serves our region with transportation demand management services for commuters and employers and is part of a larger brand serving central and southwest Virginia. Our partners in this brand include the Roanoke Valley-Alleghany Regional Commission and West Piedmont PDC. We offer services to anyone traveling in our region and NRV employers, including information and support for cycling and walking, carpoolridematching, vanpool startup, transit, Ride Home Rewards, and telework assistance.

The Department of Rail and Public Transportation (DRPT) provides operating funding to commuter assistance programs across Virginia. The agency provides funding at an 80% match of project costs, with local investment at 20% of costs, through the Commuter Assistance Program (CAP) Operating Assistance. The goal of the CAP Operating Assistance grant program is to mitigate traffic congestion through the elimination of single occupant vehicle (SOV) auto trips by shifting SOV trips to carpool, vanpool and transit.

The Commission is proposing an estimated \$125,000 budget for FY2026-27, of which \$25,000 is local funding provided by the Commission and a \$100,000 match by DRPT. Attached is a resolution of support for the board to consider; this support is required by DRPT. The budget primarily funds staff time and outreach efforts, advertising, and community partnering. The program works best when drivers AND riders participate. Matching commuters through their work site improves carpool match rates.

We currently have over 1,500 members registered in the NRV representing 162 employers – more than 67% live and work in the NRV. Our annual growth rate is better than 4% since 2022. We see the most growth during events encouraging commuters to try a commute alternative.

This fiscal year we have been working on outreach to commuters through social media, a newsletter, and community and workplace tabling such as the Active Commute at Virginia Tech, job fairs, and farmers’ markets. DRPT also conducts marketing campaigns such as the upcoming DRPT Connects Commuters, and we support those efforts relevant to our region’s transportation options.
