# V. REVIEW OF MUTUAL CONCERNS AND COMMISSIONERS' REPORTS

Mr. Lawson reported a BBQ restaurant opened in Pembroke recently and is doing well. Mr. Horton reported the City of Radford recently implemented a façade enhancement program in downtown and on August 31<sup>st</sup> there will be a Triwizard Tri-Mile Trail Race in Bissett Park. Mr. Johnson reported the Town of Christiansburg is working on the Market Place development and noted the former Meadows Golf Course will be developed as a residential neighborhood. He also shared the Hill Golf Course in Blacksburg recently re-opened and held a ribbon cutting event. Mr. Law reported plans were submitted recently for a 170-unit residential neighborhood in Pembroke. Mr. Harvey reported ReNew the New will be held 8/24 in Floyd County, 8/31 in Radford, Montgomery County, and Giles County, and 9/7 in Pulaski County.

# VII. EXECUTIVE DIRECTOR'S REPORT

Mr. Byrd provided a summary report in the Commission agenda packet. He reported the Appalachian Regional Commission (ARC) grant program held a public input meeting for the FY20 Program Design. ARC staff from D.C. and VA Dept of Housing and Community Development (DHCD) toured recent ARC investments in the New River Valley. The tour included the Floyd Innovation Center, New River Community College ACCE Program and Millstone Kitchen, the shared-use community kitchen at Prices Fork Elementary School.

The Regional Commission is working with Giles County on securing technical assistance from the US EPA program, Recreation Economies for Rural Communities. Staff received notice Giles County is a semi-finalist. The assistance will help advance work to connect communities to natural resources.

NRV Rail 2020 will host a legislative reception on October 3<sup>rd</sup>, 5:30-7:00pm, at the Great Road on Main in Christiansburg.

On September 12<sup>th</sup> there will be a bi-regional meeting of all elected officials in the New River Valley and Roanoke Valley to receive a briefing on Virginia Tech growth and Virginia Tech-Carilion research initiatives.

### A. Appalachian Regional Commission Visit

Ms. Holmes and Ms. Sanderson provided updates on some of the New River Valley projects funded by DHCD and ARC. Ms. Sanderson shared key points from ARC in D.C. which included the Federal Co-Chair's initiative on substance abuse and general economic conditions of the greater Appalachia region. Based on ARC guidelines and economic performance in the region, all of the New River Valley counties are designated as Transitional, which equates to 50/50 matching grants when pursing ARC funding.

# B. FY20 Program of Work for the Regional Commission

Mr. Sharp provided an overview of the FY20 Work Program. He highlighted the process utilized by staff to keep everyone on track with project progress and project billing. Many of the FY20 projects are focused on grant administration which is attributed to successful implementation grants written the previous fiscal year.
